### Padmabhushan to Prof. T.K. Oommen

ISS congratulates **Prof. T.K. Oommen**, Emeritus Professor of Sociology at JNU for being awarded with the **Padmabhushan** by the President of India. After Prof. M.N. Srinivas, Prof. M. S. Gore and Prof. Andre Beteille, he is the fourth sociologist to be awarded with the Padmabhushan. Prof. Oommen is a sociologist of international acclaim and was the first Asian to become the President of the International Sociological Association (1990-1994). He was the key person behind the successful conduct of the 9<sup>th</sup> World Congress of Sociology in New Delhi 1986 and was able to raise a substantial amount which was transferred to the Indian Sociological Society. He was the President of the ISS (1997-1999) and introduced the Research Committees following the ISA pattern.

### Lifetime Achievement Award 2007

The two doyens of Sociology, **Prof. Yogendra Singh** and **Prof. (Smt.) Leela Dube** received the Lifetime Achievement Award 2007 during XXXIII All India Sociological Conference, held at Dharwad. The remarkable contributions made by these sociologists expanded the horizons of sociological literature and raised the standards of Indian Sociology to international heights.

## XXXIII ALL INDIA SOCIOLOGICAL CONFERENCE, DHARWAD

### A Brief Report

The XXXIII AISC was held in Karnatak University, Dharwad on Nov.29 to Dec.1, 2007. The theme of the conference was "State, Civil Society and Social Justice". The Post Graduate Department of Studies and Research in Sociology of Karnatak University and the Karnataka Sociology Association played host to the Conference. It was attended by over one thousand delegates who included a sizeable number of young sociologists. Besides the Inaugural and Valedictory Sessions, the Conference was enriched by 4 Symposia and sessions of 21 Research Committees.

The inaugural session was presided over by Prof. P. K. B. Nayar, President of the ISS. Padmabhushan Prof. M.S. Gore inaugurated the proceedings of the Conference. This was followed by the Presidential Address. The theme of the address was "Social Justice in a Globalised World". Prof. Michel Wieviorka, President of International Sociological Association (ISA) delivered the Keynote Address. He spoke on "Can the concept of Integration still help us? State and Society in a Global World". Prof. C.A. Somasekharappa, Organising Secretary of the Conference welcomed the dignitaries and delegates and Prof. Anandkumar, Secretary of ISS, proposed the vote of thanks.

A major event of the conference was the presentation of Lifetime Achievement Awards to two doyens of Sociology, Prof. Yogendra Singh and Prof. (Smt.) Leela Dube.

Another unique event was the inauguration of the Golden Jubilee Celebrations of Karnatak University Department of Sociology. The celebrations were inaugurated by Prof. Yogendra Singh, Emeritus Professor of Sociology at JNU.

The MN Srinivas Memorial Lecture was delivered by Padmabhushan T.K. Oommen, Emeritus Professor of Sociology at JNU, a former President of International Sociological Association and also of ISS. The theme of his presentation was "*Disjunctions between field, method and concept: An appraisal of MN Srinivas*".

The first Symposium was titled "*Affirmative Action in India*" and was chaired by Prof. J.R. Panda, HOD, Sociology of Jammu University. There were 3 speakers. Dr. Nandu Ram, Professor of Sociology at Jawaharlal Nehru University spoke on "Status affirmation through affirmative action". Prof. John Kattakayam, Director, Academic Staff College, University of Kerala, spoke on "Dynamics of affirmative action: problems and prospects". Prof. Thomas E. Weisskopf of the University of Chicago, USA, presented a paper on "Lessons from the Experience of India and the United States with affirmative action".

Symposium II was titled "*People's Movements in India*" and was chaired by Prof. S.K. Srivastava Malavya, Chair, Department of Sociology, Banaras Hindu University. There were 3 speakers in this symposium. Prof. M.N. Karna, former Chair of the Department of Sociology, N.E. Hill University, Shillong, spoke on "Peoples' Movements in India with special focus on the North Eastern Areas". Prof. Bula Bhadra, Chair of the Dept. of Sociology, Calcutta University spoke on "Contextual, conceptual and operational facets and crevices of contemporary women's movements in India". The paper prepared by Prof. R. Kannan, Director, Academic Staff College of Madurai Kamaraj University, titled "Self-help groups as people's movement in India and civil society initiatives" was presented in his absence by Dr. Ashish Saxena of the Dept. of Sociology, University of Jammu.

Symposium III was on Karnataka Society and was titled "*Society in Karnataka: Retrospect and Prospect*". The Symposium was chaired by Prof. N. Jayaram, Managing Editor of *Sociological Bulletin* and Director of ISEC, Bangalore. Prof. Vighnesh Bhat, CESS, Bangalore acted as Rapporteur. There were nine speakers in this symposium viz., Prof. A.G. Mudbidri, Karnatak University, Dharwad; Prof. S.L. Hiremath, Gulbarga University; Prof. Jogan Shankar, Mangalore University; Prof. R. Indira, Mysore University; Prof. Y. Narayana Chetty, Bangalore University; Prof. M.N. Panini, JNU, New Delhi; Prof. G. K. Karanth, ISEC, Bangalore; Prof. B.S. Pareshe Kumar, Bishop Cotton Women's College, Bangalore and Prof. Shiva Halli, University of Manitoba, Canada.

The last in the symposia series was the International Colloquium on "*New Sociology: Perspectives from the Global South*". It was chaired by Prof. Tom Dwyer, President of Brazilian Sociological Association. The speakers included Prof. Michel Wieviorka, President of ISA; Prof. Peter Alexander, Vice President of South African Sociological Association; Prof. T.E. Weisskopf of the University of Chicago; Prof. Joseph Weidenholzer of the University of Linz, Austria and Prof. T.K. Oommen, Emeritus Professor of Sociology at JNU. The colloquium was co-ordinated by Prof. P.K.B. Nayar.

The 21 Research Committees of ISS met separately in several sessions and added vibrancy and professionalism to the whole conference. There were over 500 papers presented at these RCs. A large number of them were by young sociologists. The RC Conveners did a great job in selecting papers of high quality which enhanced the standard of the RC sessions.

The Valedictory Address of the Conference was delivered by Prof. S.K. Saidapur, Vice Chancellor of the Karnatak University.

They are advised to submit two copies of the abstracts of their papers in about 300 – 500 words to the concerned RC convenors or coordinator of the Ad-hoc group in the prescribed abstract format not later than September 30, 2008. There should be a clear mention of the name of the presenter, his/her membership number, name and number of the RC to which the abstract is being submitted. The acceptance of the abstract or otherwise will be communicated by the convenors of the respective RCs by October 15, 2008. The RC convenors are requested to send an edited copy of each abstract received by them

from paper presenters to the Organising Secretary of the conference not later than October 15, 2008. The members of the Indian Sociological Society (Life / Ordinary / Student) who have paid the RC membership fee (Rs.200/- for 2 years and Rs.400/- for 5 years) per Research Committee of which they have become members alone are eligible to present their papers in the conference. The paper presenters will have to register themselves for the conference by paying the delegation fees as shown below.

It would be possible for the Organising Committee to include only those abstracts in the Abstract Book which are received before October 31, 2008.

**THE CITY OF JAIPUR**

## RCs AT DHARWAD

### RC-02: Marriage, Family and Kinship

Four technical sessions and one business meeting were organised by the RC-02. In the first session the discussion focused on reconceptualising marriage, family and kinship in the context of national/global challenges. Dr. M. N. Shrivastava chaired the session. In the second session, a symposium was organised with senior colleagues Prof. A. Ramanama, Prof. Anuradha Bhoite, Prof. K. Gopal and Prof. I. P. Modi as speakers. The discussion was around theoretical and methodological issues in the study of the institutions of Marriage, Family and Kinship. Prof. Ramanamma chaired the session. Third session was devoted to Marriage and Marital Relations and was chaired by Prof. Indu Mathur. Fourth session focused on Family: Changing Functions and Relations and was chaired by Dr. Prabhakar Draxe. In all, seventeen presentations were made including the guest speakers. The committee 02 is planning a seminar on The Process of Global Changes and Marriage and Family in India in collaboration with Patna University in the second week of November. Details will be communicated to members and others concerned when ready.

### RC-03: Economy, Polity and Society

12 papers were presented at the conference in four sessions. The first session was broadly devoted to theoretical perspectives, which focused on the issues of civil society, social capital, and social exclusion. The second session broadly focused on empirical studies dealing with social justice for different marginalised groups in India. Session three in line with the main conference theme discussed on governance, identity, empowerment, and human security issues. Fourthly an Interactive Session on Affirmative Action was held. The Panel Members were: Prof. Thomas Weisskopf, and Prof. Satish Deshpande, who spoke about their respective research on affirmative action in India and the US, raising salient issues of policy concern in the two countries in the present juncture. A lively interactive discussion followed all the sessions.

### RC-06: Religion and Religious Communities

A total of 10 papers were presented on a wide range of topics like caste councils and judicial system, Bhootha cult in Karnataka, Buddhism and Hindu religion, Reproductive Health status of Muslim women, Muslim PG Girl students and their values and aspirations, role of NGO's and tribal empowerment with special reference to Gujarat, Television - Gender and Religion in post liberal India, Dynamics of Hindu Religion, etc. It was extensively discussed as to how the patriarchal values and domestication of women are reinforced and marketed thorough religious symbols via media. Above all the

deliberations focussed on how the religious rites and rituals have largely become status symbols than devotion in a globalised social context. Besides regular sessions RC also organised a symposium on Religion and Development chaired by Dr. Anil Mudbidri and Dr. B.K. Swain, Nagpur University, spoke on "Weber's views on Religion and Economic Development".

### RC-07: Rural, Peasant and Tribal Communities

36 papers were presented in RC 07 in various sessions which discussed on the three broad areas; Rural Communities in Transition (10 papers), Tribal Communities: Problems and Prospects (8 papers) and Peasants in Transitional Society (18 papers). The major areas discussed under rural communities were rural migration, rural women, Dalits, SHGs, rural problems. The highlights of Peasant in traditional society covered globalisation and its impact on agriculture, technology in agriculture, land reforms in agrarian transition and rural development. The study of tribal communities brought to light the issues such as Law and Justice in tribal society, Social mobility, Impact of globalisation, tribals in transition. Distinguished Professors like J.K. Pundir, Gulshetty B.S. and S. Gurusamy had chaired and conducted the deliberations in the identified thematic areas. On an average 50 participants attended each session.

### RC-09: Dalits and Backward Classes

A total of 12 papers were presented on a range of topics that included Atrocities on Dalits in Gujarat, Problems of Education among Paura Karmikas, Problem of Education among the Tribal Women in Assam, Elements Responsible for Antagonistic Relationship between the Backward Classes and the Dalits, The Growing Awareness of the Indian Women of their Rights, Prospects of Extension Communication Strategies in the Transfer of Tasar Culture Technology to Motivate SC, ST and EWS of the Society in Non-Traditional Areas of Kolhapur District for Rural Development, Interpersonal Relations of Scheduled Caste Employees at their Work Place, Socio-Economic Conditions & Problems of Scheduled Caste Agricultural Labourers, Anusuchit Jatio Mein Ashprushyata, Mandal Commission and the Identity of Other Backward Classes in India, Dalito Ka Vartaman Samajik Pariddshy and Dr Ambedkar and the Social Mobility of Dalits

### RC-10: Gender Studies

30 papers were presented in RC 10 that was spread over five different sessions. The first technical session was a round table discussion on the topic New Technologies and Marginalisation, which was organised

jointly with RC11 and RC21. Prof. Raj Mohini Sethi introduced the theme while Prof. Sherry Sabbarwal, Prof. Vipul Bhadra and Prof. S.A. Salunkhe initiated the discussion. The second session was devoted to issues of gender discourse on violence in Indian society. The house observed that issues of domestic violence find some relief in the Domestic Violence Act, however, the issue of falling sex ratios needs concerted efforts of the state, civil society and the academic community to initiate a “save the daughter revolution”. In the third and fourth sessions papers were presented on contexts and issues of gender such as gender & work, gender & education and trans-gender & sports. The third session was chaired by Prof. Indu Mathur and Prof. M.N.Panini while the fourth session was chaired by Prof. Saguna Pathy and Dr. Madhu Nagla. Last session dealt with issues of women empowerment and was chaired by Prof. Ramanamma and Prof. Sarita Kamra.

#### **RC-11: Environment and Society.**

34 Abstracts were received and 26 papers were presented in three sessions. There were 8 papers on the first theme i.e. “Environment and State”; 9 papers each on the other two themes namely “Environment and Civil Society” and “Environment, Development and Social Justice”. Prof. R.B. Patil, Convener of RC 11, chaired the business session. The sessions were attended by a large number of members of other RCs and students and Research Scholars of Karnataka University. The house is concerned more on environmental action particularly in terms of judicious planning of policies and programmes by the State and people’s action to save environmental resources for the future generations. The cash prize (Rs. 1000/-) for Young Scholar below the age of 30 years, for presenting the best Research Paper was given to Mr. Sarada Prasanna Das, Research Scholar, JNU, for his paper entitled “ Globalisation and Indigenous People: Question of Survival”. A new feature was added this year in terms of Round Table Discussion jointly organised by RC10, 11,13 and 21 on the theme “ New Technology and Marginalisation”.

#### **RC-12: Population, Health and Society**

A total of 15 papers were presented in RC 12 which explored and elaborated the theoretical as well as empirical health issues among the different segments of the population. There were serious discussions on the topics such as the Interface between Sociology and Public health, Nursing and public health, Health Dynamics and Marginalised Communities, Feminisation of HIV/AIDS, Urban Population dynamics, Community-led health promotion, Nutritional Status of Women, Perception of Illness and Health, Adolescent Health and Sexual Risk Behaviour, Commercial sex workers, Soft drink consumption, etc. RC 12 held its elections in which Prof. Tulsi Patel, Department of Sociology, University of Delhi

was elected as the Convener, Dr. Mohmamd Akram, Aligarh Muslim University as the Secretary and Prof. Suhita Chopra Chatterji and Prof. Nagendra Prakash as the executive committee members. The term of the co-convener (Dr.Arima Mishra) and Treasurer (Dr. M.Thamilarasan) was renewed for a period of two years. RC 12 brought out its first *Newsletter* which was widely circulated during the conference.

#### **RC-13: Science, Technology and Society**

RC-13 conducted five technical sessions and a business session. A Round Table Discussion was organised in collaboration with three Research Committees—RCs-10, 11 and 21 on the dialectical relationship between Information and Communications Technologies (ICTs) and Marginalisation. Professor Bipul Kumar Bhadra, introduced the theme and drew attention to the positive and negative impacts of the new technologies and urged for framing and implementation of an inclusive science and technology policy. A total of 19 papers were presented in the other four sessions which covered a variety of issues like indigenous practices and techniques, organisational culture in software firms, tissue technology, Information Technology Act, intellectual property rights and Technology in parenthesis with globalisation, gendered consumption, rural development, education, etc. The sessions were chaired by Prof. Bipul Kumar Bhadra and Prof. D. C. Choudhary. The papers generated active participation and fruitful intellectual interactions. Finally, in the business session the concerned members renewed the term of the office bearers for a further period of two years (2008-2009) and another member was included in the Executive Committee.

#### **RC-15: Social change and development**

RC 15 organised four sessions and one discussion at Dharward Conference. The first session was chaired by Dr. Chura Giri and Dr. B. N. Prasad which discussed on the theme – State, civil society and Nation Building. The presentations indicated the new trends of debates both at theoretical and praxis levels in Indian civil society. The second session on Tribal world – Issues for development, chaired by Dr. M Purvachar. thrust the need of further sociological inquiries with theoretical depth. The third session was on Subaltern issues and change which was chaired by Dr. Ravindranath Rao. Session four focused on dynamics of social change which was chaired by Dr. B. Ramamurthy. A discussion was also held on increasing religiosity and caste demands, chaired by Dr. Madhu Nagla.

#### **RC-18: Sociology of Crime and Deviance**

The issues of crime and deviance were addressed from gender and developmental perspectives by the paper presenters and also in the discussions followed. The vulnerable sections of society; particularly, children, women

and tribals were focussed. The house expressed concern with the growing prevalence and incidence of crime and deviant behavior in the Indian scenario. The solutions to tackle the menace were also debated and urged to develop context specific sociological approach to address the issues. Out of the 13 abstracts submitted, 9 meaningful presentations were made and these touched four main issues (a) of children, specially of child abuse and entry of children in crime; (b) women related concerns, namely, violence against women, including reference to new forms and understanding problems of domestic violence victims; causes of criminality among women with specific reference to gender dimensions; sexual harassment of women at the work place; consequence of gender biased policing and need for more women in the work force; (c) problems among the tribal; of deviant behavior in particular of alcoholism and (d) importance of education in dealing with crime and deviance related problems.

#### **RC-19: Ageing and Social structure**

32 abstracts were submitted to RC out of which 24 papers were presented in the five academic sessions. The participants discussed a wide array of issues pertaining to the changing social structure and the consequences upon the different age groups in Indian society. Along with empirical validations many papers critically appraised the various theoretical approaches on ageing and outlined practical solutions for a healthy living space. The major themes that fuelled the intellectual discourse were, the living space : the old age homes- the family linkages, the socio-psycho-health problems of elderly, ageing: the rural-urban dichotomy, retirement- the adjustment issues, legal rights and future prospects for a healthy life, etc. The academic sessions were chaired by Prof. Jacob John Kattakayam, Dr. Vijayalakshmi Reddy, Dr. Jayashree, Dr. Aravind Joshi, Dr. M.V. Lakshmi Devi and Dr. Chandrashekar. In the business session it was decided to open a new website and newsletter for the RC.

#### **RC-21: Social Problems and Marginalised Groups**

RC 21 conducted one round table discussion, one panel discussion and five regular sessions at the Dharward Conference. Round table discussion on New Technologies and Marginalisation was held by RC 21 in collaboration with RCs 10, 11 and 13 and chaired by Prof Raj Mohini Sethi. Panel discussion was held on :State and Social Justice and Marginalisation- Affirmative action and De-Marginalisation, chaired by Prof. R. Shankar, Barathidasan University and Prof. A. Karuppiah. There were twenty three scholarly presentations in 5 regular sessions. The sessions were chaired by Prof. B. B. Mohanty, Prof. S. M. Dhahivale, Prof. B. C. Barik, Dr J. Krishnamurthy and Prof. Indira respectively.
